Office of District & Sessions Judge/District Development Committee(DDC), District Buner invites sealed bids under national competitive bidding for the procurement/supply/service and installation of the Water Filtration Plants with the sponsoring/fund of Access to Justice Development Fund (AJDF) in light of Rule 6 (2) (b) "Single Stage Two Envelops" procedure of KPPRA Rules 2014, from contractor/manufacturers/service provider or their Authorized Dealer/suppliers/representative only registered with the Income/Sales tax and reflected on Active Taxpayer List (ATL) of FBR/KPPRA.

- 1.** Bids Documents, containing detailed descriptions including evaluation criteria and other terms & conditions and advertisement may be downloaded from www.districtcourtsbuner.gov.pk website or may be obtained from Accounts Branch the office of District & Sessions Judge, Buner.
- 2.** The bidders are required to submit bid security (in original) @ 2% of the quoted value in the form of Call Deposit Receipt (CDR) in the name of "District & Sessions Judge Buner". An affidavit is mandatory in the technical bid that bid security is placed in the financial bid.
- 3.** Each envelop shall contain separate Technical and Financial Bid clearly marked in bold legible letters. The firms shall provide their complete information along with their postal as well as valid E-mail address and Phone Number on each envelop.
- 4.** Bids should be complete in all respect shall reach the office of the undersigned by 11:30 hours on **21.04.2026**. Only Technical Bids shall be opened @ 12:00 hours on the same day in the conference room of District & Sessions Judge, Buner in presence of the members of DDC and the bidders/representatives, who may choose to attend and financial bid of only successful bidders in technical evaluation will be opened on next day while financial bid of unsuccessful bidder will be returned sealed/unopen. Bid received after due date & time will not be considered.
- 5.** The bid applications shall be followed by an affidavit to the effect that the prospective bidder is not blacklisted by any provincial or federal department, organization, autonomous body.
- 6.** The firm must be registered with KPPRA and must have an active PEC registration with the specific code for supply and installation of solar system. All the admissible taxes (I. Tax, GSTetc) will be deducted as per rules.
- 7.** Competent authority reserves the right to reject any or all the bids as per provisions in rule 47 of KPPRA Rules 2014.
- 8.** The competent authority may increase/decrease the number of items as per the sanction/released budget of AJDF Scheme.
- 9.** Interested bidders may contact the DDC before submission of bid for any query/confusion on the given official Number or visit the office in duty hours.
- 10.** Delivery and installation of the items may be supplied/installed in District Courts Buner & Tehsil Court Totalai as per direction of DDC Buner which will be clearly mentioned in supply order later on.
- 11.** All the purchases will be subject to availability of funds.
- 12.** The contractors are advised to visit the spot/location before submitting the quotations.
